By taking part in the Festival, the Artist gives up any claims against the Organizers for such damage or loss. The Artist accepts all risk to their own artwork and property from any cause.

The Artist is fully responsible for getting proper insurance to cover their artwork and other property.

If the Artist is selected for the Festival, the Artist must participate at the show. In the event of inclement weather, the event will be moved indoors. The Organizers will not provide tents or electricity. Limited number of six-foot tables available. Please let Organizers know ASAP if you need a table.

The Artist agrees to protect and hold the Organizers harmless from all claims, demands, legal actions, losses or costs – including reasonable attorney fees – that result from the actions or negligence of the Artist or anyone working with the Artist. This includes any claim related to promises or responsibilities in this Agreement.

The Artist gives the Organizers permission to use the Artist's name, information about the Artist's work and images of the Artist's work for display, promotion and publicity.

The Artist is responsible for transporting, delivering, picking up, re-packing and re-transporting their artwork for the Festival. If any artwork is left behind at the end of the Festival, the Artist gives the Organizers permission to handle the artwork on the Artist's behalf at the Artist's own risk and expense.

The Artist confirms that all artwork is original and does not violate anyone else's copyright.

The Artist will receive 100% of the money from their booth sales and is solely responsible for collecting and reporting all taxes on those sales.
